

Millers Falls Rod & Gun Club rental fee: Part One

Extra Fees apply if MFRGC is NOT catering your event.

Festivals & Bigger functions 500 + Need to sign Rental Agreements

This rental agreement allows the parties access to the grounds and must be cleaned prior to leaving the grounds *on the day of the event*, unless prior arrangements have been approved.

Rental fee with or without MFRGC catering:

Outdoor: \$400.00 Daily pavilion and grounds (*Max Capacity 300 under pavilion*)

You may choose to add your own table & chairs out on grounds surrounding.

Indoor: \$200.00 Daily Club House Hall (folding tables & chairs) *Max Capacity 70*

Included with rental

Any rental/food/cleaning deposit fees due prior to event.

Horseshoe pits – Volleyball net – Ample Dance floor and stage area

Picnic tables – Enough picnic tables to cover your guests plus 10% at 10 seats per table

For “Head Table” we have; (8’, 6’, 3’) folding table, cake table, caterer tables.

Table cover rolls (White paper)

For seating at Head Table (We have limited cushioned folding chairs available)

Outside Restrooms available

Use of kitchen on day of event (including, stove, ovens, refrigeration) **for additional fee**

Gas Grills, BBQ Pit, Fire Pit (you supply coal & wood) **for additional fees**

Limited walk-in cooler storage can be arranged **for additional fees**

Cash Bar ***Millers Falls Rod & Gun Club Inc. has a liquor license and there is no outside alcohol allowed on property any time.***

We have a fully stocked cash bar & ATM for your convenience.

At no time may you have open fires we have the pit for that.

Please obey posted speed limits to protect the safety of pedestrians, children and pets traveling along the road.

All functions must be over by 11:00 PM unless prior arrangements have been approved.

Clean up of kitchen and grounds includes

Before 9 AM next day

❖ **Kitchen**

- All stoves, ovens, refrigerators exteriors wiped clean.
- Tables, counters, etc. cleaned and sanitized.
- Sinks, cleaned and sanitized.
- All equipment used properly cleaned and returned to proper location.
- Floor mats clean.
- Rubbish emptied; (Supplied) bag replaced.
- Floors swept and mopped.

❖ **Grounds**

- All party supplied decorations removed from property or disposed of.
- All trash barrels emptied.
- Gas grill, BBQ Pit, Fire Pit cleaned (if used).
- Benches replaced under Pavilion.

MFRGC has a license to sell alcohol and soft drinks on the premises. Function participants are not allowed to bring alcohol beverages on the grounds. Please inform your guests prior to your event. Violators will be asked to leave the premises.
